

## Pavilion Permit

The pavilion was constructed in 1980 for the benefit of all members of Chesapeake Isle Civic Association (CICA), along with their families and guests. Because of the popularity of this facility, the CICA Board of Directors has established a reservation system for equitable access to the pavilion which includes the regulations printed on the other side of this page.



1. A CICA member may reserve the pavilion.
2. The member making the reservation is asked to limit the number of guests to 50 people.
3. The Pavilion chairperson will provide keys to the cooler storage area, the games closet and the code to the bathhouse.
4. CICA requires the member reserving the pavilion to make a payment of \$50.00 to defray pavilion maintenance expenses. Checks should be made payable to CICA and forwarded to the Pavilion chairperson with the completed reservation form below. Note that the reservation is not complete until receipt of the completed form and payment.
5. The pavilion reservation includes use of picnic tables, grill, ice chests, and shared use of playground equipment, game closet, beach, and bathhouse.
6. **The inside spaces of the pavilion building are NOT included in the rental and are locked during the event.**
7. **Read and honor all rules on the reverse of this form.** Rule #3 (no pets/dogs) and Rule #8 (no watercraft or fishing in swim area) are bolded as past violations have occurred. Note that violations of any rules could result in loss of future reservation privilege.

Members reserving the pavilion accept full responsibility for compliance by their party with the regulations below:

1. Respect the rights of other property owners, who retain their right to use the parking lot, picnic tables, playground and volleyball areas, and swimming beach.
2. You are responsible for and liable for the behavior of your guests.
3. **Swim at your own risk. (No boats, kayaks, jet skis, or stand-up paddleboards in the swimming area. No fishing in swimming area.)**
4. Maintain a reasonably low noise level and limit your use of the area to the hours between 9:00 a.m. and midnight. *The Cecil County Noise Ordinance restricts noise levels from 10 pm- 6:00 am. Restrictions include music, singing, radio, etc. that can be heard 50 feet from the source. This item is enforced by Cecil County not Chesapeake Isle.*
5. Bathhouse must be kept locked when not in use.
6. Fireworks are PROHIBITED by State law.
7. Fires are limited to designated areas. You are responsible for completely extinguishing all bonfires and grills before leaving them unattended. Please observe any seasonal burn bans.
8. **Pets, either unleashed or leashed, are prohibited in the entire beach area (which includes the pavilion, picnic and playground areas, swim area, and facilities).**
9. Clean up the pavilion facilities that you use. ALL FIRES SHALL BE FULLY EXTINGUISHED. Return equipment and lock the games closet and lock all coolers in the storage area. Additionally, lock the bathhouse before leaving.
10. Return all loaned keys and equipment promptly to the Pavilion Chairperson in good condition. You must replace any lost or broken equipment.
11. CICA reserves the right to close the pavilion at any time. Closures may occur for reasons of public safety and/or dangerous weather conditions.
12. No glass containers are allowed in the pavilion and beach areas.
13. All cost-sharing contributions for use of the pavilion must be made payable to CICA only. No activities may be conducted in the pavilion or beach areas for personal profit.
14. Failure to comply with the foregoing rules and regulations will result in loss of the pavilion reservation privilege for one year.
15. Trash shall be placed in appropriate containers or removed by the reserving member. Please bag and tie all trash prior to placing it in CICA trash containers. All trash not fitting in CICA trash containers shall be taken home.
16. Recycles shall be placed in appropriate containers.
