Refer to the Fees & Dues Invoice for details on payment. Storage fee is \$20.00 per watercraft for the Dinghy/Kayak racks. If space allows, it is acceptable to store more than one watercraft per rack space, and storage fee payment would be based on the number of rack spaces used. The storage fee also applies to storing Sunfish and Catamarans at the approved locations on the grounds of the Harbor. Contact the "Dinghy Master" with questions or concerns (contact information is below). If you are submitting this form/payment after Feb. 15, 2025, additional fees may apply.

Rack assignments will be made in the spring and is subject to space limitations.

Please note that each watercraft must have the owner's name visible on it.
