

Chesapeake Isle Civic Association Annual Meeting

2:00 p.m.: Meeting for all property owners

~4:00 p.m. (or immediately following the meeting of property owners): Meeting for CICA members

As outlined in the Chesapeake Isle Civic Association (CICA) Bylaws, the Annual Meeting of CICA members is held on the third (3rd) Sunday in May and is preceded on that same day by a meeting of all property owners. At these meetings, the proposed budgets for the Common Property and Roads (community maintenance) and CICA Membership are discussed and approved. These proposed budgets and other important budget-related information were in the April/Spring newsletter that was sent to all owners on April 7, 2026, and posted on our website.

In accordance with the Chesapeake Isle Bylaws:

- **All property owners** have the right to vote on the proposed **community maintenance budget and applicable agenda items** (one vote/lot).
- **All CICA members** can vote on the **CICA membership budget** and **for the CICA Board of Directors** (one vote/household).

Voting: Details regarding the following two options for voting were emailed on April 13, 2026: (1) proxy voting for those who could not attend in-person. (*The deadline for requesting mail-in ballot(s) was April 30, 2026. Completed ballots must be returned in accordance with the procedure listed on the ballot.*) and (2) in-person voting at the pavilion during the meeting. We will **NOT** be conducting a virtual meeting on ZOOM.

All property owners and/or CICA members who did not previously request and then submit a mail-in ballot(s) can still vote during the meeting in person. Details are highlighted below.

Proxy Voting Process

All mail-in ballot requests needed to be received by Thursday, April 30, 2026.

All mail-in ballots need to be received by Saturday, May 16, 2026.

You can also hand-deliver your ballot, **in a sealed envelope**, on the day of the Annual Meeting to the CICA Vice President/designated Board member. They will be available for this purpose from 1:00-1:30pm.

Ballots must be received prior to the start of the Annual Meeting in order to be counted.

In-Person Attendance/Participation

If you wish to attend in person, we recommend that you download the meeting documents on your phone or other mobile device prior to the meeting, as limited copies of the presentation will be available at the meeting. (These documents have been sent via e-mail.)

Also note the following:

- Please bring your chairs, as there will be limited seating at the picnic tables.
- Please bring your own pen for completing paper ballots.
- In-person participants should arrive by 1:40 p.m. to sign-in. (The meeting begins promptly at 2:00 p.m.)

Please note that there is a CICA covered dish social following the meeting of CICA members.

CICA will provide a main dish, beverages, and paper products.

If possible, please bring a side dish or dessert to share!
